### Participant and Speaker Bios

**ADENIYI, Olusegun.** WCFIA Fellow, 2010-2011 (Nigeria). A former Editor of THISDAY Newspaper and current chair of its editorial Board, Mr. Adeniyi holds a bachelor's degree in International Relations and a Masters in International Law and Diplomacy. He began his journalism career in December 1990. On May 30, 2007, he was appointed Spokesman to the late Nigerian President Umaru Musa Yar'Adua, a position he occupied until YarAdua died on May 5, 2010. Mr. Adeniyi is the author of five books: *The Last 100 Days of Abacha*; *Abiola's Travails*; *Fortress on Quicksand*; *POLITRICKS: National Assembly under Military Dictatorship and Power*, and *Politics and Death: A front-row account of Nigeria under the late President Yar'Adua*, which he completed while he was a Fellow at the Weatherhead Center for International Affairs. Mr. Adeniyi is a Fellow of the Nigeria Leadership Initiative and is also a founding member of the National Stakeholder Working Group of the Nigeria Extractive Transparency Initiative. He is married with three children.

**AIROLDI, Adele.** CFIA Fellow, 1994-1995 (Italy). Degree in classics, master degrees in the environment and in polar studies. EU official at the Secretariat of the EU Council of Ministers (1981- 2004), in the fields of research, environment (including international negotiations, particularly climate change), health and consumer protection. Since retirement, active on Arctic issues with special attention to the EU-Arctic interface.

**AKINOLA, Charles 'Diji.** WCFIA Fellow, 2010-2011 (Nigeria). Dr. Akinola is the Director General, Office of Economic Development and Partnerships, state of Osun, Nigeria. He is also Team Leader, Osun Rural Enterprise and Agriculture Program (O-REAP). He was also the founding partner, Hybridea Partnership, a public sector innovation and strategic management consultancy between 2008 and 2010. Dr. Akinola was the Founder/CEO of Enterprise for Development International (EfDI), a development sector market leader based in Lagos, Nigeria from 1990 to 2008, and Country Director of TechnoServe, a US-based international development agency between 1993 and 1998. He taught at University of Ibadan Nigeria from 1984 to 1989 and was on the faculty of the Pan-African Institute for Development (PAID) Buea, Cameroon 1990. He was also the Nigeria National Coordinator of the Sustainable Tree Crop Program (STCP). He was most recently a Mason Fellow at the Harvard Kennedy School of Government and a Fellow at the Weatherhead Center for International Affairs.

**ALMALIKY, Muhamed.** WCFIA Fellow, 2012-2013 (Iraq). Dr. Almaliky is an Iraqi American physician, a long- standing political activist and the founder of the Iraqi American Institute, a foreign policy think tank concerned with studying and analyzing Iraq's foreign policy with a focus on US-Iraq relations. After completing his medical education at Basra University, Iraq and later at Temple University, Philadelphia, he obtained an MPH and MPA from Harvard University. Subsequently, he returned to Iraq to consult in health system reform, and electoral processes. He currently divides his time between Philadelphia where he practices medicine and cardiology at the University of Pennsylvania, and Cambridge, where he continues to build his institute.

**ALMSTEIER, Stephen.** WCFIA Fellow, Spring 2013 (United Kingdom). Mr. Almsteier is a security risk manager, analyst and adviser. He most recently spent six years in Aceh as the security and post conflict adviser to BRR, the Indonesian government ministry established to coordinate the unprecedented international response to the 2004 tsunami. Previously he was employed as a security risk manager in Afghanistan by the Asian Development Bank and he has worked with international agencies in various positions in the Balkans, Middle East and Asia. Mr. Almsteier spent 15 years as a commissioned officer in the British military in peacekeeping and operational roles worldwide. The culmination of this service saw him deployed in Bosnia at the crisis of the conflict and during the transitional period following the Dayton accord.

**ANDERSSON, Karl-Olof.** WCFIA Fellow, 2004-2005 (Sweden). Karl-Olof Andersson is since September 2012 in Pyongyang as Sweden's Ambassador to the Democratic People's Republic of Korea. He was deputy director and head of the Diplomatic Training Program, Ministry for Foreign Affairs, Stockholm 2010-2012.

Before that he was the deputy director at the Asia Department 2005–2010. His postings include Tallinn, Estonia (2000–2004); Berlin, Germany (1997–2000); and Athens, Greece (1992–1995). Andersson was educated at The Johns Hopkins University, (MA, political science) and University of Lund (BA, business and languages).

**BABALI, Tuncay.** WCFIA Fellow, 2009-2010 (Turkey). Mr. Babali entered the diplomatic service in 1995. Currently ambassador to Canada, he served previously in Bulgaria, the United States (twice), and in London. He also served as deputy chief of cabinet to the Turkish President (2003-2004). Ambassador Babali earned a master's degree from SOAS, University of London and a PhD from the University of Houston. He is married with three sons.

**BLEHA, Thomas.** CFIA Fellow, 1978-1979 (United States). Mr. Bleha was a U.S. Foreign Service officer for 26 years, specializing in Asia, particularly Japan. He also served overseas in Korea and Germany. After leaving the Foreign Service, he worked in public affairs and fundraising at the Johns Hopkins' School of Advanced International Studies and George Washington University's Elliott School of International Affairs. In 2000, he received an Abe Fellowship from the Japan Foundation and produced a Foreign Affairs article and a book on America's loss of Internet leadership. He is now working on another book, aimed at answering the question: what are the uses of diplomacy?

**BLOOMFIELD, Steven B.** Steven B. Bloomfield is executive director of the Weatherhead Center and a member of the Center's Executive Committee. He previously served as the Center's associate director, director for public information, and director of its Fellows Program. While at Harvard he has also been the program director of the Latin American Scholarship Program of American Universities (LASPAU). His other professional experiences include classroom teaching in the Boston Public Schools and at an independent school in New York City, working in rural development and education as a Peace Corps volunteer in the Ecuadorian Andes, and serving as a member of a settlement-house staff and as a community organizer in Manchester and London, England. He holds degrees from Harvard's Graduate School of Education and Harvard College.

**BOYD, Steve.** CFIA Fellow, 1982-1983 (United States). Mr. Boyd is the owner of MacDonald Boyd and Associates, Seattle, Washington ([www.macboyd.com](http://www.macboyd.com)), consulting as a leadership strategist to CEOs, executive teams and corporate boards in the Pacific Northwest in both the public and private sector. He has worked with the Washington Governor's Office, King County Executive, Seattle Mayor's Office, King County Prosecutor, Seattle Parks, Seattle City Attorney, Seattle Parks, Seattle City Light, Seattle University President's Cabinet, Sellen Construction, First Security Bank Of Washington, Recreational Equipment, Inc. and WAVE Broadband. Mr. Boyd was formerly the Founder and Chief Executive of the Washington Governors' School for Citizen Leadership. He is also Board President of Global Village Media (NYC) and Executive Producer of, "John Muir in the New World", which premiered on PBS during Earth Week, April 2011 and taught through Harvard Kennedy School's Executive Seminar program (see [http://globalvillagemedia.org/new\\_muir.html](http://globalvillagemedia.org/new_muir.html)). Mr. Boyd is married to Sheryl Harmer, EdD.

**BRENTON, Anthony.** CFIA Fellow, 1992-1993 (United Kingdom). Ambassador Brenton is a British diplomat, having served from 1975 to 2008. He served in Cairo, Brussels (EU), Washington, DC and Moscow (British Ambassador 2004-2008). He was also the British negotiator on climate change, human rights and other UN issues. Ambassador Brenton wrote a book on international environmental diplomacy, and is currently a Fellow of Wolfson College Cambridge and a commentator on Russia and other international issues.

**BRICKER, Paul.** WCFIA Fellow, 2010-2011 (United States). Colonel Bricker, U.S. Army (Ret), joined The Livingston Group in January 2013 after 28 years of distinguished service, culminating in his assignment as the Chief of the U.S. Army's Senate Liaison Division in the Office of Congressional and Legislative Affairs. Prior to his service on Capitol Hill, he was the 2010-2011 Army Senior Fellow at Harvard University's Weatherhead Center for International Affairs. In addition to his work on Capitol Hill, Mr. Bricker also served in the Pentagon as the Strategic Planning Division Chief in the Office of the Chief of Army Public Affairs, and as the Aide de Camp to the Vice Chairman of the Joint Chiefs of Staff. His experience operating at the highest levels

of our military provided him with valuable insight into developing creative and nuanced strategies on which the military, administration and Congress can all agree. Mr. Bricker is a former Army Aviator with a distinguished record of service, having served in Iraq, twice in Afghanistan, and in South Korea. He commanded the 82nd Airborne Division's Combat Aviation Brigade and led soldiers on multiple combat tours in Afghanistan and Iraq. His most recent experience includes managing the operations and maintenance for over 160 U.S. and NATO aircraft and the design, construction, and ongoing support of expeditionary operating bases in Afghanistan and Iraq.

**CHINYANTA, N. Justin.** WCFIA Fellow, 2008-2009 (Zambia). Mr. Chinyanta is the founder and Chairman of the Loita Group (Loita Holdings Corporation Africa), the Mauritius based holding company for Loita Capital Partners International, a pan-African investment banking firm; Fintech International, a financial IT firm, and Loita Transaction Services, which specializes in African bank switching and electronic transfer operations. A former Vice President at Citibank and HSBC's Africa Regional offices, Mr. Chinyanta, a barrister with an LLB degree from the University of Zambia, is a graduate of the Fletcher School of Law and Diplomacy (Tufts University) and Fellow of Harvard University's Weatherhead Center for International Affairs. He serves as Vice Chair of the Zambia Bond and Derivatives Exchange (BADEX) as well as Executive Vice President (Southern Africa) for the Africa Business Roundtable and is one of the pioneer members of General Colin Powell and Secretary Madeleine Albright's Initiative for Global Development Frontier 100 CEOs.

**CONSTAIN, Silvia.** WCFIA Fellow, 2012-2013 (Colombia). Ms. Constain has served most recently as a consultant to two organizations, the United Nations Conference on Trade and Development (UNCTAD) and the Asia-Pacific Economic Cooperation (APEC) forum. She has also worked at the Embassy of Colombia to the United States, serving as head of congressional affairs and, more recently, as deputy chief of mission. Other previous assignments include work at the Colombian Trade Bureau (deputy director), Colombia's Ministry of Trade in Bogota (director of foreign investment and services), Colombia's mission to the World Trade Organization (international trade negotiator). Ms. Constain was educated at Los Andes University, Bogotá.

**COOPER, Patricia.** WCFIA Fellow, 2002-2003 (United States). Ms. Cooper served for eight years as a senior executive appointee of the Government of Canada to provide advice and monitor the effects of federal legislation on women and children. Since moving to Colorado, she served as Executive Director of the Children's Museum of Denver where she directed the financial turnaround of the Museum with a focus on early childhood learning. She currently serves on the Board of Capital Sisters International, the Advisory Board of the Urgent Action Fund, The Colorado Women's College, School of Public Affairs at the University of Colorado and the Leadership Council for the Harvard Divinity School. Ms. Cooper is currently the Global Director of The Women's Regional Network: Afghanistan, Pakistan and India, a collaborative network of women leaders from civil society organizations in South Asia to lead and take action to address the issues of security, corruption, and militarization of aid and development as they impact women's lives in the region.

**DAMBAZAU, Abdulrahman Bello.** WCFIA Fellow, 2012-2013 (Nigeria). Lieutenant General Dambazau (retired) served most recently as Army chief of staff. He held many positions during his long career in the military, including general officer (commanding two divisions), chief of Army standards and evaluation, and principal general staff officer to the Minister of Defence. He is the founder and chairman, board of trustees, of the Foundation for the Victims of Child Abuse and the Nigerian Society for Victimology. He also serves as a director of the New York-based International Police Executive Symposium. He was a member of the faculty, National Defence College, Nigeria, with appointments as directing staff, and then subsequently as director, department of higher military organization and operations (for the course on leadership, national security and strategic studies). General Dambazau was educated at the University of Keele (doctorate) and at Kent State University (master's and bachelor's degrees).

**DOMÍNGUEZ, Jorge I.** Jorge I. Domínguez is Antonio Madero Professor for the Study of Mexico, vice provost for international affairs, special advisor for international studies to the dean of the faculty of arts and sciences, and chairman of the Harvard Academy for International and Area Studies. Professor Domínguez was

the Director of the Weatherhead Center for International Affairs from 1996 to 2006. He is the author or editor of various books, among them *Cuban Economic and Social Development: Policy Reforms and Challenges in the 21st Century*; *Debating U.S.-Cuban Relations: Shall We Play Ball?*; *Contemporary U.S.-Latin American Relations: Cooperation or Conflict in the 21st Century?*; *La política exterior de Cuba, 1962-2009*; *Consolidating Mexico's Democracy: The 2006 Presidential Campaign in Comparative Perspective*; *The United States and Mexico: Between Partnership and Conflict, 2nd ed.*; *Constructing Democratic Governance in Latin America, 3rd ed.*; *The Construction of Democracy: Lessons from Practice and Research*; *Between Compliance and Conflict: East Asia, Latin America, and the "New" Pax Americana*; *Democratic Politics in Latin America and the Caribbean*; *Technopols: Freeing Politics and Markets in Latin America in the 1990s*, and many other books and articles on domestic and international politics in Latin America and the Caribbean. A past president of the Latin American Studies Association and a past board chairman of the Latin American Scholarship Program of American Universities, he currently serves on the editorial boards of *Political Science Quarterly*, *Foreign Affairs Latinoamérica*, *Cuban Studies*, *Foro internacional*, and *Journal of Cold War Studies*. He was series editor for the Peabody Award-winning Public Broadcasting System television series *Crisis in Central America*. His current research focuses on the international relations and domestic politics of Latin American countries.

**DRAPER, Charles.** WCFIA Fellow, 2004-2005 (United Kingdom). Mr. Draper was born and brought up mainly in London, and apart from a year in the United States, was educated at Highgate School and Cambridge University, where he read physical and social sciences. He joined the Ministry of Defence as a Graduate Trainee in 1974. Over the next 30 years he had a variety of roles on defence policy, finance, procurement and corporate management. In 2004-2005 he undertook a Fellowship at Harvard. From October 2005 he was corporate services director for the central 10% of the MOD, responsible for services including finance, personnel, information management, security, business continuity, safety, HQ accommodation, and estates. Since leaving the MOD in April 2009, he has pursued a variety of interests, and now runs an astronomy group, is a school governor, a treasurer for a charity supporting a local youth orchestra, and with his writer/singer wife Julia looks after homestay language students.

**DRUKE, Luise.** CFIA Fellow, 1987-1988 (Germany). Luise Druke received a doctoral degree in Pol. Sc. from Hannover University, was a WCFIA Fellow and Associate (1999-2000), a Harvard Law School Visiting Researcher and a Dr. h.c in law from Schumen University. She holds a MPA (1987) from Harvard; MA degrees in economics, finance and management from Webster University, and in international law from Brussels Free University. Ms. Druke headed Offices and missions of the UN High Commissioner for Refugees (UNHCR) for nearly 30 years in Asia, Latin America, Africa and Europe. She is a Harvard Humanitarian Initiative Fellow, a part-time faculty member at Leibniz University Hannover, and UN Studies co-founder and co-chair at Suffolk University. She is the author or editor of various books and articles, including on UN and international human rights and refugee policy and law and is working on a book on UNHCR Innovations in Refugee Protection. Studies: Vietnamese boat people, Chilean and Namibian exiles and returnees, and new cooperation with ICT technologies and partnerships

**DUBROW, Marsha.** WCFIA Fellow, 2011-2012 (United States). Dr. Dubrow is CEO of The Dubrow Group, a global consulting entity focused on strategy, leadership and organizational development. Additionally, she serves as the Religious Leader and Cantor of an American synagogue in New Jersey. A published scholar, she is a Resident Scholar at the Center for Jewish Studies at the Graduate Center of the City University of New York. She will participate this summer as a Fellow of Brandeis University's Summer Institute in Israel Studies and will travel to Israel with visits that include meetings with Palestinian Authority leadership in Ramallah, as well as Bedouin leadership in the Negev. A former Director and active Member of the International Women's Forum, she is a Board Director of the United Nation's World Food Program and has traveled most recently to East Africa - Ethiopia and Kenya - on behalf of WFP. Dr. Dubrow is also an award-winning composer.

**DUSSEY, Christian.** WCFIA Fellow, 2012-2013 (Switzerland). Ambassador Dussey has most recently served as the head of the Crisis Management Center of the Swiss Ministry of Foreign Affairs. The Center coordinates the governmental crisis response system during major incidents affecting Swiss citizens abroad (disasters, political upheavals, terror attacks, hostage-taking). Previously, he headed the International Security

Section of the Ministry of Foreign Affairs. Among other diplomatic postings, he served as political counselor at the Embassy of Switzerland in Moscow (Russia) and as diplomatic adviser to the president of the Swiss Confederation. Prior to joining the diplomatic corps of the Foreign Ministry, he served for five years at the Strategic Intelligence Service of the Swiss Ministry of Defense. Ambassador Dussey is also a general staff officer in the Swiss armed forces. He gives lectures on crisis management at IMD, a leading global business school based in Lausanne (Switzerland) and at other universities. He was educated at the Fletcher School of Law and Diplomacy, Tufts University (MA), at the University of Fribourg, Switzerland (MA), and at Georgetown University (exchange student).

**DUSSEY-CAVASSINI, Tania.** WCFIA Fellow, 2012-2013 (Switzerland). Ms. Dussey combines experience in law enforcement, diplomacy, management consulting and executive coaching. She has most recently worked at IMD, a world leader in executive education. As Director of Partnership Programs, she has been responsible for developing IMD's custom programs for multinational companies, designing transformational learning and development initiatives that blend capability building with business impact. She also coaches executives in the areas of leadership and public speaking. She serves as a consultant to the United Nations Institute for Training and Research (UNITAR), training diplomats across the African continent and in Asia in multilateral diplomacy, negotiations and complex decision-making. Prior to these activities, she served as a Swiss career diplomat for more than ten years and was posted in Paris, Berne – Political Directorate, Moscow, and Geneva. She gained experience both in bilateral and multilateral diplomacy. She started her career as a lawyer in 1991 working with the Swiss Ministry of Justice in the realm of international criminal matters and extraditions proceedings. She was educated in law at the University of Lausanne, and music at the University of Music Lausanne, Switzerland.

**EFTHYMIU, Petros.** WCFIA Fellow, 2012-2013 (Greece). Mr. Efthymiou has had a distinguished career in politics and in journalism. Between 2004 and 2012, he served simultaneously in the parliamentary assembly of the Organization for Security and Cooperation in Europe (OSCE) and in the Hellenic parliament, rising to leadership positions in both. He was elected president of the OSCE parliamentary assembly in 2010, and was for three years, from 2009 to 2012, chief whip of the governing party PASOK. He participated in key parliamentary committees, among them defense and foreign affairs, and also European affairs, as a member of parliament. From 2000 to 2004, Mr. Efthymiou served as minister for education and religious affairs, introducing a number of educational reforms. As a journalist earlier in his career, he has worked both in print, which included five years as editor-in-chief of "Anti" magazine, and on TV. He received his bachelor of arts degree in philosophy from the University of Ioannina.

**ENGBERG, Katarina.** CFIA Fellow, 1986-1987 (Sweden). Dr. Engberg is Deputy Director General in the Swedish MoD. She is the author of "The EU and Military Operations. A comparative study," (forthcoming) and a frequent commentator on security policy in the Swedish media. Katarina Engberg was educated at Uppsala University (PhD) and Harvard's Kennedy School of Government (MPA).

**FAIRBANKS, Michael.** WCFIA Fellow, 2011-2012 (United States). Michael Fairbanks was a U.S. Peace Corps teacher in Kenya (1979-1981). He has been a founder and chief executive in both the private and NGO sectors; he is Senior Advisor since 2001 to President Paul Kagame of Rwanda. He co-authored Harvard Business School's book on business strategy in emerging markets, "Plowing the Sea, Nurturing the Hidden Sources of Advantage in Developing Nations," and has written for the Financial Times, New York Times, Washington Post, Huffington Post, Christian Science Monitor, Philanthropy Magazine, and The Harvard International Review. He is a Director of the Rwanda Biomedical Board, which oversees that nation's health care system; the Akilah Institute for Women, Rwanda's first women's college; and Silver Creek Pharmaceuticals, which focuses on regenerative medicine. He is a citizen of the United States, the European Union (Ireland), and Rwanda.

**FELMAN, MARC.** WCFIA Fellow, 1998-1999 (United States). Strategic counterterrorism planner, sponsored under broad charter by a government agency to integrate and implement strategic operational plans. Department of Defense, Department of Homeland Security, FEMA, and the National Counterterrorism Center, consultant/strategic planner. Incirlik Air Base, Turkey, wing command during Operations Northern Watch,

Enduring Freedom, and Iraqi Freedom. Strategy and Policy Planner at Chairman of the Joint Chiefs of Staff, NATO AIRSOUTH Director of Staff, and Air Force Deputy Director for Operational Plans and Joint Matters. Decorated Instructor and Evaluator Pilot in military aerial refueling versions of Boeing 707 and McDonnell Douglas DC-10. Defense Superior Service Medal, Legion of Merit (2), Distinguished Flying Cross. Mackay Trophy and Jabara Award recipient. DPA (abd) Public Administration (U of AL), MS Systems Mgt (USC), MS Air and Space Art and Science (SAASS), BS Science (USAF Academy). Certified PMP and Villanova U Six Sigma Black Belt.

**FERRER, Liliana.** WCFIA Fellow, 2004-2005 (Mexico). Ms. Ferrer has been a Mexican Career Foreign Service Officer since 1992 and is currently the Head of Section for Political and Border Affairs at the Embassy of Mexico in Washington, DC. While a Fellow at the Weatherhead Center for International Affairs, her research topic was entitled “Possibilities and Limits of Advocacy Work in the United States: The Mexican Government’s Perspective.” Prior to being at Harvard, Liliana served as Special Advisor to the Undersecretary of Economic Affairs and International Cooperation and as Spokesperson at the Mexican Ministry of Foreign Affairs in Mexico City. Ms. Ferrer has been commissioned at the Mexican Consulates in San Diego, Los Angeles and Guatemala City. Ms. Ferrer is the mother of two children, María Cecilia, who was born in March of 2000, and Alexander Douglas, who was born in January of 2002. She is married to Douglas Smurr.

**FONTES, Robin.** WCFIA Fellow, 2012-2013 (United States). Colonel Fontes, United States Army, comes to Harvard from Afghanistan, where she served most recently as commander, Regional Support Command – North, NATO Training Mission. A graduate of the United States Military Academy at West Point, Colonel Fontes has had a distinguished career in the military, with assignments in Pakistan, Tajikistan, South Korea, and Germany, to note just a few of the many places in which she has served. Colonel Fontes is the recipient of numerous military decorations, including the Defense Superior Service Medal, Bronze Star, and Defense Meritorious Service Medal. She also holds two masters degrees, one from the University of Washington, where she studied international affairs (focus on Russia, eastern Europe, and Central Asia), and a second from the National War College, where she focused on national security and strategic studies.

**GABEL, Patricia.** WCFIA Fellow, 2001-2002 (United States). Ms. Gabel is General Counsel to the Supreme Court of Vermont and the Deputy State Court Administrator of Vermont. Prior to joining public service, she worked as an international business lawyer in New York, Montreal, and Vermont. She designed and taught courses in negotiation and conflict resolution in the Department of Political Science at Concordia University in Montreal, where she also consulted on matters of governance and the resolution of multi-party, multi-issue conflicts. Patricia is the writer, researcher, and co-producer of the CBC documentary film, *Her Brilliant Career*, and the founder and first President of the International Women's Forum of Canada. She has served as an officer and member of the board of directors of a number of non-profit organizations, including the International Women's Forum and the Leadership Foundation, both headquartered in Washington D.C. She is a member of the Board of Directors of Vermont Public Television.

**GARAVINI DI TURNO, Sadio.** CFIA Fellow, 1986-1987 (Venezuela). Ambassador di Turno is a member of the board of directors of the Venezuelan-Italian Chamber of Commerce. He is a Fulbright Scholar and Political Scientist, University of Rome. He earned his PhD in Political Science from the Central University of Venezuela. Ambassador di Turno’s previous positions include: Venezuelan Ambassador to Sweden, Guatemala and Guyana, Vice-Minister of Justice, Professor of International Relations at Simón Bolívar University and Catholic University Andres Bello, Venezuela. He has authored various publications on Venezuela, democracy, the international system and Guyana’s foreign policy.

**GARVER, Mathew.** WCFIA Fellow, 2012-2013 (United States). **GOURDON, Jean-Pierre.** WCFIA Fellow, 1990-1991 (France). Mr. Gourdon is a French diplomat who was posted in London, Damascus, Ottawa and Georgia/Russia. He has experience in nuclear proliferation, diplomatic negotiation, and has jointly assisted in brainstorming in the case of the Georgian-South Ossetia war. He is also an IT Consultant.

**GUTIERREZ, Luis.** CFIA Fellow, 1986-1987 (Mexico). Dr. Gutierrez's academic background includes B.A., M.A., Ph.D. and postdoctoral studies in economics and 37 years of experience in structural reforms, regulatory, infrastructure and energy economics. He worked as principal economist in the Industry and Energy Department at the World Bank, on sector reforms and regulatory activities in emerging market economies, and as infrastructure economist at the Interamerican Development Bank. **HEHIR, J. Bryan.** Professor Hehir is the Parker Gilbert Montgomery Professor of the Practice of Religion and Public Life. He is also the Secretary for Health Care and Social Services in the Archdiocese of Boston. His research and writing focus on ethics and foreign policy and the role of religion in world politics and in American society. **HENNINGSEN, Jørgen.** WCFIA Fellow, 2004-2005 (Denmark). M.Sc. in chemical engineering, 1965. Associate professor Technical University of Denmark 1965-1973. Head of unit, Dep. Dir.Gen. Ministry of the environment DK 1963-1987. Director, DG Environment and Principal Adviser DG Energy and Transport, EU Commission, 1987 -2006. Commission negotiator for the UN Climate Convention and Kyoto Protocol. After

retirement in 2006, member of the Danish government's "Commission on climate change" (2008-2010). Presently active in energy and climate debate in Denmark and the EU.

**JAROS, Kyle.** Mr. Jaros is a fifth-year doctoral student in the Department of Government at Harvard studying Chinese politics and the political economy of regional and urban development. His dissertation project looks at the drivers of "metropolitan focus" in China's contemporary development, relying on comparative provincial case studies and analysis of provincial- and city-level statistical data. He attended Princeton University as an undergraduate, earning an A.B. with highest honors in Public and International Affairs and a certificate in Chinese Language and Culture in 2005. **KARTASASMITA, Ginandjar.** WCFIA Fellow 2000-2001 (Indonesia). Advisory Council of the President, Republic of Indonesia, Professor of Public Administration, Brawijaya University; Visiting Professor, National Graduate Institute for Policy Studies, Tokyo, Japan; Chairman, House of Regional Representatives (DPD), 2004-2009; Vice Chairman, the People's Consultative Assembly (MPR), 1999-2004. Other previous positions include: Coordinating Minister of the Economy, Finance, and Industry/Chairman of National Development Planning Agency (Bappenas); Minister of Mines and Energy; Chairman, Investment Coordinating Agency (BKPM).

**KAUFMANN, Greg.** WCFIA Fellow, 2001-2002 (United States). Retired Colonel, U.S. Army (1975-2005). From 2009 to 2012, Mr. Kaufmann was employed as a Foreign Affairs Analyst with HQDA, G-3/5/7, Multinational Strategy and Programs Division, working on army strategy and security cooperation issues. He also completed doctoral course work and comprehensive exams in Georgetown University's Doctor of Liberal Studies Program and is currently working on his dissertation full time.

**KELMAN, Herbert C.** Herbert Kelman is the Richard Clarke Cabot Professor of Social Ethics, Emeritus, at Harvard University and was (from 1993 to 2003) Director of the Program on International Conflict Analysis and Resolution at Harvard's Weatherhead Center for International Affairs. He received his Ph.D. in Social Psychology from Yale University in 1951. He is past president of the International Studies Association, the International Society of Political Psychology, the Interamerican Society of Psychology, and several other professional associations. He is recipient of many awards, including the Socio-Psychological Prize of the American Association for the Advancement of Science (1956), the Kurt Lewin Memorial award (1973), the American Psychological Association's Award for Distinguished Contributions to Psychology in the Public Interest (1981), the Grawemeyer Award for Ideas Improving World Order (1997), and the Austrian Medal of Honor for Science and Art First Class (1998). His major publications include *International Behavior: A Social-Psychological Analysis* (editor; 1965), *A Time to Speak: On Human Values and Social Research* (1968), and *Crimes of Obedience: Toward a Social Psychology of Authority and Responsibility* (with V. Lee Hamilton; 1989). He has been engaged for many years in the development of interactive problem solving, an unofficial third party approach to the resolution of international and intercommunal conflicts, and in its application to the

Arab-Israeli conflict, with special emphasis on its Israeli-Palestinian component. Professor Kelman is a Faculty Associate of the Weatherhead Center for International Affairs.

**KHALLAF, Tamim.** WCFIA Fellow, 2008-2009 (Egypt). Mr. Khallaf has served in the Egyptian Ministry of Foreign Affairs for the past 10 years focusing on international security, disarmament, and nonproliferation issues. He previously served in Egypt's Mission to the United Nations in Geneva and currently serves in Egypt's Embassy in Brazil. He received a Master of Science in International Relations from the London School of Economics and a Master of Arts in Political Science from the American University in Cairo. He was a Fellow at Harvard University's Weatherhead Center for International Affairs and a Visiting Fellow at the James Martin Center for Nonproliferation Studies at the Monterey Institute of International Studies in California. **LASSEN, Christina.** WCFIA Fellow, 2012-2013 (Denmark). Ambassador Lassen comes to Harvard directly from Damascus, where she for the last three years has served as Denmark's ambassador to Syria and to Jordan. Previous assignments include: Head of Department at the Ministry of Foreign Affairs' Executive Secretariat; Private Secretary to the Permanent Secretary of State; Special Advisor to the Prime Minister (Middle East and Transatlantic Affairs); Embassy Secretary for Political Affairs at the Danish Embassy in Washington, D.C. Ambassador Lassen has a Master's degree and a Bachelor's degree (Business and International Relations) from Copenhagen Business School.

**LE, H.B.** WCFIA Fellow, 2012-2013 (United States). Commander Le, U.S. Navy, has most recently served as the executive assistant to the commander, U.S. Seventh Fleet. Previously, he commanded *USS Lassen* (DDG 82), forward deployed to the western Pacific Ocean and home ported in Yokosuka, Japan. He has served in five ships and two afloat staffs during his 20-year career. Educated and commissioned at the U.S. Naval Academy, Cmdr. **LIESENFELD, Bodo.** WCFIA Fellow, 2009-2010 (Germany). Originating from Hamburg, Germany, Mr. Liesenfeld was the CEO and Chairman of a privately held transportation and logistics enterprise with a global presence for 30 years. He moved to Boston in mid-2009 and got involved in transatlantic relations by building bridges between Massachusetts and Boston and the City State of Hamburg in the fields of urban development and energy efficiency. He was appointed Hamburg Ambassador, representing Hamburg in the Northeast of the United States. Traveling and working with and in Latin America since the mid 70's made him President of the German Latin America Association since 2006. Prior to this position she worked for the Department of Defense in Europe, overseeing NATO personnel management programs as well as enlargement plans at the Partnership for Peace Consortium, George C. **LÖHR, Friedrich Ludwig.** WCFIA Fellow, 2007-2008 (Germany). Friedrich Ludwig Löhr is a Visiting Professor of Government at Suffolk University and the University of Rhode Island, after a 37-year career in the German Foreign Service. He was Consul General of Germany to the New England states from August 2008 to June 2012, following a year as a Fellow at Harvard University's Weatherhead Center for International Affairs. Before coming to Boston he served as German Ambassador to North Korea and Minister (Deputy Chief of Mission) at the German Embassy in Beijing, China. Friedrich L. Löhr was born in Ingolstadt/Bavaria in 1947 and lived in southern Germany until his graduation in law at Heidelberg University in 1971. **MARCIANO, Yael.** WCFIA Fellow, 2011-2012 (Venezuela). Mrs. Marciano, a native from Venezuela and 2012 Weatherhead Fellow, graduated as a lawyer in Caracas in 1995. After finishing her training as a corporate lawyer, she moved in 1998 to Washington DC where she completed a Masters in International Law and International Service at American University. Mrs. Marciano worked for the Inter-American Development Bank from 2000 to 2002 in the Social Capital, Ethics and Development Initiative, a project aimed at introducing the discussion of ethics into development project planning and policy-making. The project has since spread to most countries in the region. She worked for Hispanic News Press LLC as a columnist and currently provides international and political analysis for Globovision and Union Radio in Venezuela and for the Huffington Post. **MARIANO, Stephen J.** WCFIA Fellow, 2011-2012 (United States). COL Mariano is a Senior Fellow in the Chief of Staff of the Army's Strategic Studies Group. Previously he was the Army's Senior Fellow at Harvard University's Weatherhead Center for International Affairs. He holds a PhD in War Studies from the Royal Military College of Canada and is a former instructor of Military Strategy and Comparative Military Systems at the US Military Academy, West Point, NY.

**MASOUD, Tarek.** Professor Masoud is an associate professor of public policy at Harvard University's John F. Kennedy School of Government. A political scientist and Middle East specialist, his research focuses on political development in countries that are poor and unfree. He is particularly interested in the processes by which governments become more accountable to, representative of, and responsive to the needs of their people. **MILLER, Steven E.** Steven E. Miller is Director of the International Security Program, Editor-in-Chief of the quarterly journal, *International Security* and also co-editor of the International Security Program's book series, Belfer Center Studies in International Security (which is published by the MIT Press). **MORAST, Bernd.** WCFA Fellow, 2009-2010 (Germany). 1974-75 Research in South Africa on Apartheid; 1977 Ph.D. in Social Sciences at University of Konstanz, Germany; 1978 Entering German Federal Foreign Office; 1981-1984 Cultural and Press Attaché at German Embassy in Kuala Lumpur; 1984-1987 Press Attaché at German Consulate General in New York; 1990-1993 Deputy Head of Mission at German Embassy in Yaounde; 1996-1999 Head of Mission at German Embassy in Bujumbura; 1999- 2001 Consul General in Thessaloniki; 2001-2004 Head of Mission at German Embassy in Nouakchott; 2004-2007 Chancellor's Office Berlin 2007-2009 Head of Mission at German Embassy in Luanda; 2009-2010 Fellow WCFA; 2011-2012 Head of Mission at German Embassy in Bandar Seri Begawan; 2012 Retirement.

**NYE, Joseph S.** Joseph S. Nye, Jr. is University Distinguished Service Professor and former Dean of Harvard's Kennedy School of Government. He received his bachelor's degree summa cum laude from Princeton University, won a Rhodes Scholarship to Oxford, and earned a Ph.D. in political science from Harvard. He has served as Assistant Secretary of Defense for International Security Affairs, Chair of the National Intelligence Council, and a Deputy Under Secretary of State. His most recent books include *Soft Power*, *The Powers to Lead*, and *The Future of Power*. He is a fellow of the American Academy of Arts and Sciences, the British Academy, and the American Academy of Diplomacy. In a recent survey of international relations scholars, he was ranked as the most influential scholar on American foreign policy, and in 2011,

Foreign Policy named him one of the top 100 Global Thinkers. Professor Nye was Director of the Center for International Affairs from 1989 to 1993 and is currently a WCFIA Faculty Affiliate.

**OLIVERO, Nelson Rafael.** WCFIA Fellow, 2011-2012 (Guatemala). Born in Guatemala City 1962, Lawyer LL.M. and Diplomat. Foreign Service Posts in Paris, Geneva, Brussels, Bonn, Berlin, Seoul, Guatemala and Rome. Has published a thesis, *El Nuevo Derecho del Mar*, UFM Guatemala 1986, and WCFIA Research Paper *Climate Protection in Guatemala, Potential Development in Green Energy* in 2012. Presently First Secretary and Consul, Embassy of Guatemala in Italy and Permanent Representation to the UN Bodies based in Rome.

**OLUPONA, Jacob K.** Professor Olupona, noted scholar of indigenous African religions, joined the Faculty of Divinity and the Faculty of Arts and Sciences in 2006. His current research focuses on the religious practices of the estimated one million Africans who have emigrated to the United States over the last 40 years, examining in particular several populations that remain relatively invisible in the American religious landscape. His earlier research ranged across African spirituality and ritual practices, spirit possession, Pentecostalism, Yoruba festivals, animal symbolism, icons, phenomenology, and religious pluralism in Africa and the Americas. In his book *City of 201 Gods: Ilé-Ifè in Time, Space, and the Imagination*, he examines the modern urban mixing of ritual, royalty, gender, class, and power, and how the structure, content, and meaning of religious beliefs and practices permeate daily life. His other books include *Òrìṣà Devotion as World Religion: The Globalization of Yorùbá Religious Culture*, co-edited with Terry Rey, and *Kingship, Religion, and Rituals in a Nigerian Community: A Phenomenological Study of Ondo Yoruba Festivals*, which has become a model for ethnographic research among Yoruba-speaking communities. In 2012, he was named one of Harvard's Walter Channing Cabot Fellows, for distinguished publications. Olupona has received grants from the Guggenheim Foundation, the American Philosophical Society, the Ford Foundation, the Davis Humanities Institute, the Rockefeller Foundation, the Wenner-Gren Foundation, and the Getty Foundation. He has served on the editorial boards of three influential journals and as president of the African Association for the Study of Religion. In 2000, Olupona received an honorary doctorate in divinity from the University of Edinburgh in Scotland, and in 2007 he received the Nigerian National Order of Merit, that country's prestigious award given each year for intellectual accomplishment in the four areas of science, medicine, engineering/technology, and humanities. Professor Olupona is also a Faculty Associate of the Weatherhead Center for International Affairs.

**PASSMORE, Edwin W.** WCFIA Fellow, 2007-2008 (United States). COL Passmore recently retired from the US Army after serving for over 30 years. Commissioned into Military Intelligence from the University of Connecticut, he has held various positions in intelligence, foreign affairs, and security cooperation. Deployed for three years to Kuwait, Iraq, and Afghanistan, his particular focus has been Latin America where he has worked in every country, including being on the US country teams in Argentina, Brazil, Venezuela, Uruguay, Paraguay and Mexico. He has Master's degrees from Georgetown University and the Army War College and has done postgraduate work in strategic intelligence. He was the Senior Army Fellow at WCFIA in 2008. **PREISINGER, Johannes.** CFIA Fellow, 1997-1998 (Germany). Ambassador Preisinger studied political science at University Munich and Free University Berlin, graduating as Dipl.Pol. (1966) and Dr. phil. (1975). After his post-graduate studies at College of Europe (Bruges, Belgium 1966-1967), Ambassador Preisinger worked as scientific staff at the Institute for International Politics and Security in Ebenhausen (1968-1973). He joined the German Diplomatic Service in 1973 with assignments as division-head of nuclear non-proliferation and staff assignments at diplomatic representations in Osaka-Kobe, Bangkok, Tokyo and San Francisco. **QIN, Yaqing.** WCFIA Fellow, spring 2013 (China). Yaqing Qin, Ph.D. in Political Science (University of Missouri-Columbia), is executive vice president and professor of International Studies at China Foreign Affairs University. He is also vice president of China National Association for International Studies, China Country Coordinator for the Network of East Asian Think-tanks (NEAT), member of the Foreign Policy Advisory Group of the Chinese Foreign Ministry, and member of the Chinese People's Institute of Foreign Affairs. He is member of the Academic Committee of School of International Relations of Peking University and member of the Academic Committee of the Institute of Advanced Social Sciences of Fudan University. Dr. Qin was on the Resource Group for the High-Level Panel on Threats, Challenges and Change organized by the then UN Secretary-general Kofi Annan (2003) and worked as special assistant to the Chinese eminent person for the China-ASEAN Eminent Persons' Group (2005). Previously he was a TV-journalist, correspondent and bureau chief of YLE/Finnish TV in Brussels and in Berlin, and the moderator of a weekly foreign affairs and economy magazine programs as well as moderator of Morning TV-show.

**ROUYER, Muriel.** Muriel Rouyer, Adjunct Professor of Public Policy, has been a Professor of Political Science in France since 2004, at the University of Nice (2004) and Nantes (since 2005). She taught in various international contexts (The University of Chicago and G. Washington University in Paris, Master degree and International Program at Sciences-Po Paris, The University of Belarus in exile in Vilnius, University Gaston Berger in Senegal). Her fields of expertise are the European Union, theories of democracy and the rule of law, French, European and American Feminism. **RUBIN, Trudy.** CFIA Fellow, 1975-1976 (United States). Trudy Rubin writes a twice weekly foreign affairs column for The Philadelphia Inquirer that runs in many other US papers. Before joining The Inquirer in December 1983 she was the Middle East correspondent for The Christian Science Monitor, and a staff writer for The Economist of London. She has special expertise on the Middle East, South Asia and Russia, and appears frequently on radio and TV. In recent years she has traveled repeatedly to Iraq, Afghanistan, Pakistan, Egypt, Syria, Tunisia, Lebanon, Jordan, Turkey, Israel, and the West Bank. In 2001, Ms. Rubin was a finalist for the Pulitzer Prize in commentary. In 2008 she won the Edward Weintal prize for inter- international reporting. In 2010 she received the Arthur Ross Award for distinguished analysis of foreign affairs from the American Academy of Diplomacy. She is the author of *Willful Blindness: The Bush Administration and Iraq*. She is a graduate of Smith College and the London School of Economics.

**RUTE, Maive.** WCFIA Fellow, 2012-2013 (Estonia). Ms. Rute is the European Commission's representative in the Fellows Program. Since 2009, she has been director for biotechnologies, food, and agriculture research, DG Research and Innovation, at the European Commission (EC). Prior to this position, she was EC director of SMEs competitiveness and entrepreneurship. Before joining the Commission, Ms. Rute was CEO of the Estonian Credit and Export Guarantee Fund KredEx. She was educated as agricultural economist at the Estonian University of Life Sciences, earned her MBA from Danube University (Krems, Austria), and received an MA in international politics from CERIS, Brussels.

**ROGOFF, Kenneth.** Kenneth Rogoff is Thomas D. Cabot Professor at Harvard University. From 2001-2003, Rogoff served as Chief Economist at the International Monetary Fund. His 2009 book with Carmen Reinhart, *This Time is Different: Eight Centuries of Financial Folly* has been very widely cited by academics, policymakers and journalists. One regularity that Reinhart and Rogoff illustrate is the remarkable quantitative similarities across time and countries in the run-up and the aftermath of severe financial crises. In general, they show that for financial crises, the differences between emerging markets and advanced countries are far less pronounced than previously believed. Reinhart and Rogoff have subsequently written a series of papers on debt overhang, the aftermath of financial crises, central bank policy and exchange rates that will form the core of a planned second volume. Rogoff is also known for his seminal work on exchange rates and on central bank independence. His treatise *Foundations of International Macroeconomics* (joint with Maurice Obstfeld) is the standard graduate text in the field worldwide. His monthly syndicated column on global economic issues is published in over 50 countries. He serves on the Economic Advisory Panel of the New York Federal Reserve. Rogoff is an elected member of the National Academy of Sciences, the American Academy of Arts and Sciences, and the Group of Thirty. He is also an international grandmaster of chess. He was the 2011 winner of the biennial Center for Financial Studies Deutschebank Prize. **SAICH, Anthony.** Professor Saich is the director of the Ash Center for Democratic Governance and Innovation and Daewoo Professor of International Affairs, teaching courses on comparative political institutions, democratic governance, and transitional economies with a focus on China. In his capacity as Ash Center Director, Saich also serves as the director of the Rajawali Foundation Institute for Asia and the faculty chair of the China Public Policy Program, the Asia Energy Leaders Program and the Leadership Transformation in Indonesia Program, which provide training programs for national and local Chinese and Indonesian officials. Saich first visited China as a student in 1976 and continues to visit each year. Saich is a trustee member of AMC Entertainment Inc., the China Medical Board, and International Bridges to Justice. He is also the US Secretary-General of the China United States Strategic Philanthropy. He sits on the executive committees of the John King Fairbank Center for Chinese Studies and the Asia Center, both at Harvard University. He serves as the Harvard representative of the Kennedy Memorial Trust and previously was the representative for the Ford Foundations China Office from 1994 to 1999. Prior to this, he was director of the Sinological Institute at Leiden University in the Netherlands.

**SCHMUNK, Michael.** WCFIA Fellow, 2005-2006 (Germany). Ambassador Schmunk is a German career diplomat, and is currently the Minister of the German Delegation to the Organization for Security and Co-

operation in Europe (OSCE), Vienna. He was ambassador at large of the German Diplomatic Academy, Berlin (2008-2010), ambassador to Bosnia and Herzegovina (2006-2008), ambassador at large and special envoy for Afghanistan (2002-2004), ambassador to Kosovo (2000-2002) and to Azerbaijan (1994-1997). He also held diplomatic posts in the USA (1985-1987) and in South Africa (1991-1994). From 2004-2005, he worked as a senior research fellow at the German Institute for International and Security Affairs, SWP, Berlin. Before he entered the German Foreign Service in 1983, he served as a foreign and security policy adviser to the German Parliament. His research focuses on strategies, concepts and instruments for peace, state and nation building, failing and failed states, the phases of the conflict cycle and Transatlantic security. He is married to Maryann Schmunk (USA).

**SHARP, Gene.** Dr. Sharp is Senior Scholar at the Albert Einstein Institution and founded the Institution in 1983. He holds a B.A. and an M.A. from Ohio State University and a D.Phil. in political theory from Oxford University. He is also Professor Emeritus of political science at the University of Massachusetts Dartmouth. For nearly thirty years he held a research appointment at Harvard University's Center for International Affairs. He is the author of various books, including *The Politics of Nonviolent Action* (1973), *Gandhi as a Political Strategist* (1979), *Social Power and Political Freedom* (1980), *Making Europe Unconquerable* (1985), *Civilian-Based Defense* (1990), and *From Dictatorship to Democracy* (1993, 2002, and 2003). His most recent book is *Waging Nonviolent Struggle: Twentieth Century Practice and Twenty-First Century Potential*. His writings have been published in more than thirty languages.

**SIMPSON, Michael.** WCFIA Fellow, 1994-1994 (United States). Michael Simpson is Captain, USN (Ret). Following the Fellows year, Captain Simpson returned to the Navy with two years penance at the Pentagon (Navy Staff). He was next assigned to establish and command a new Mine Countermeasures Squadron for the Arabian Gulf area. His final Navy assignment was four terrific years at the University of San Diego and San Diego State University as the Professor of Naval Science and Commanding Officer of the Navy ROTC Unit. That experience fulfilled a life-long desire to teach at the university level. Captain Simpson retired from the Navy in 2003. For the next five years, he combined part-time consulting work with more extensive personal travel. He is currently press freedom director as well as director of the Press Institute, the IAPA's educational arm. **WRIGHT, Richard.** WCFIA Fellow, Fall 2011 (United Kingdom). Ambassador Wright is currently Director of UNRWA's Representative Office in New York. This UN Agency has the responsibility for providing services (social, education, health) to 5.2 million Palestine Refugees. Prior to this he worked for the European Union as Ambassador in Russia (2000-2004) and as Representative of the European Commission on the EU's Political/Security Committee.
